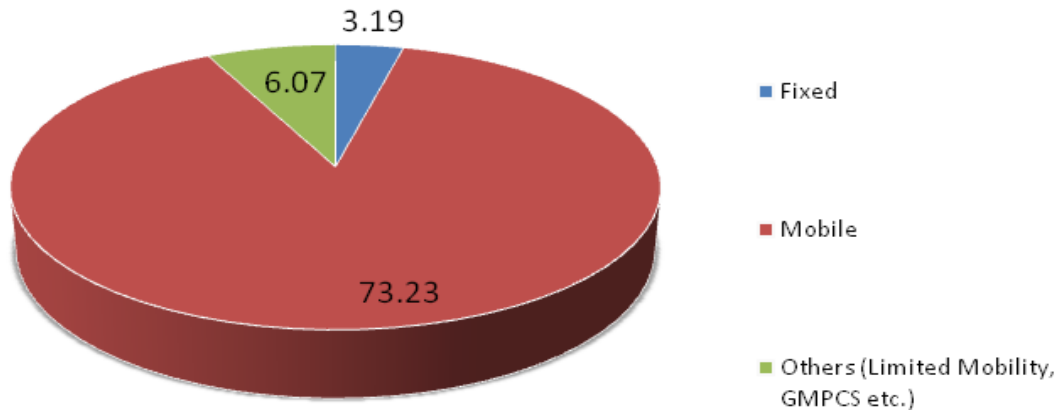

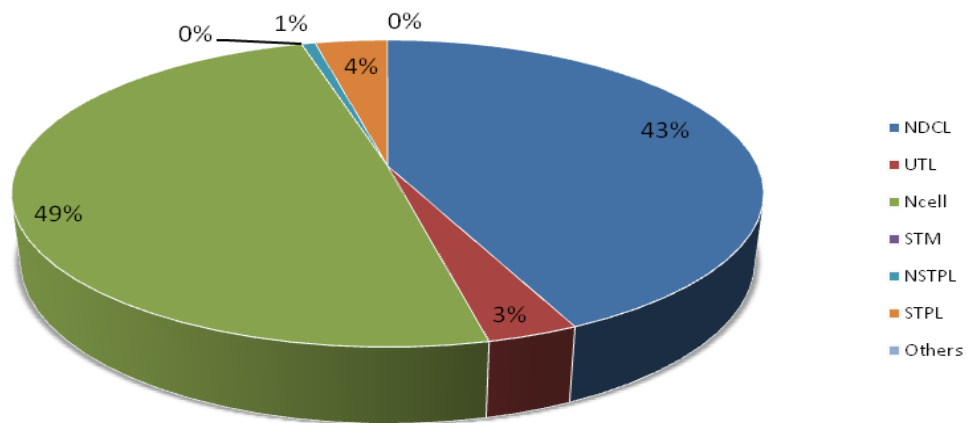

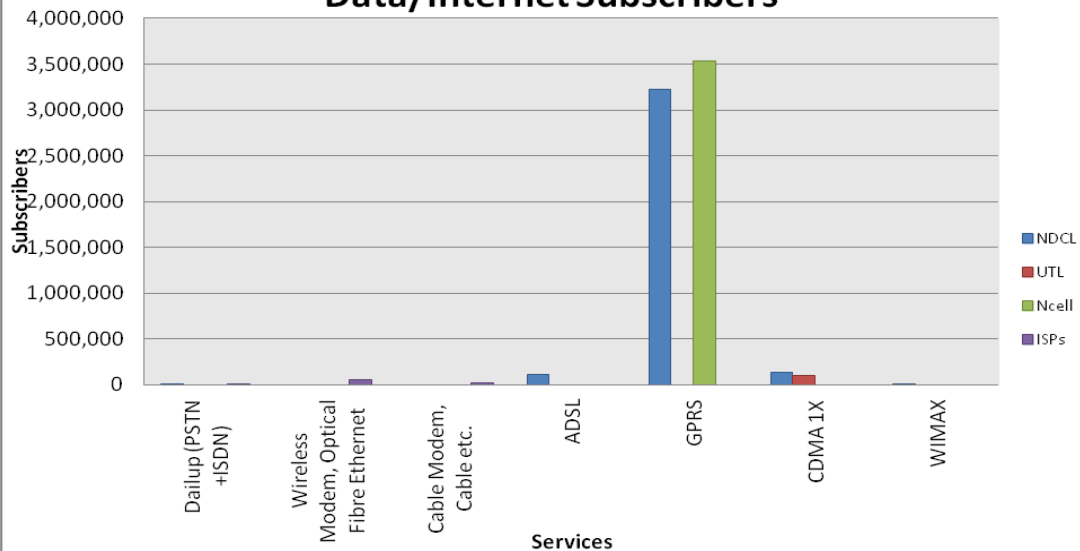
Telephone Penetration Rate



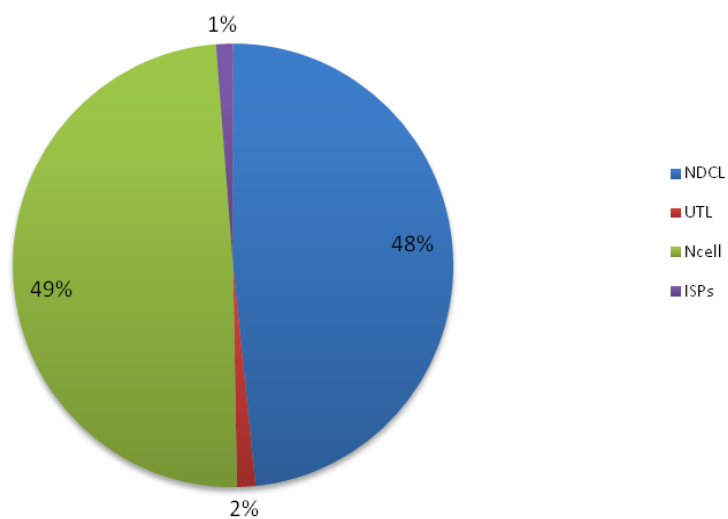
Market Share of Telephone Subscribers



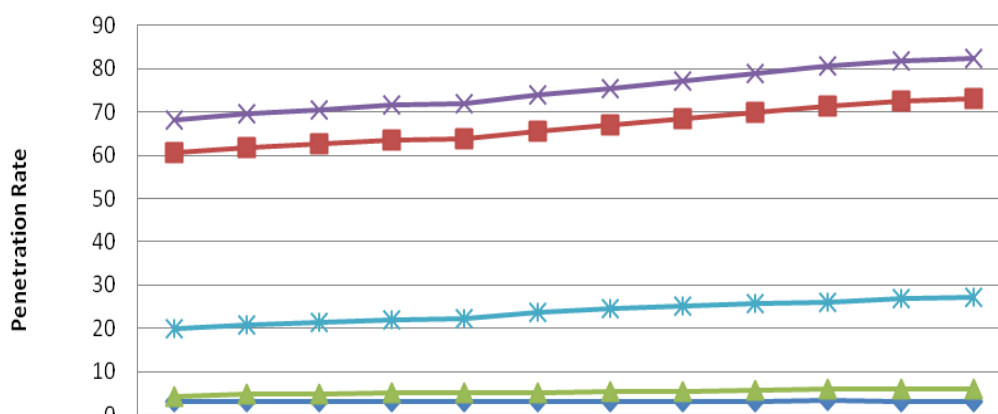
Data/Internet Subscribers



The market share of data/internet subscribers



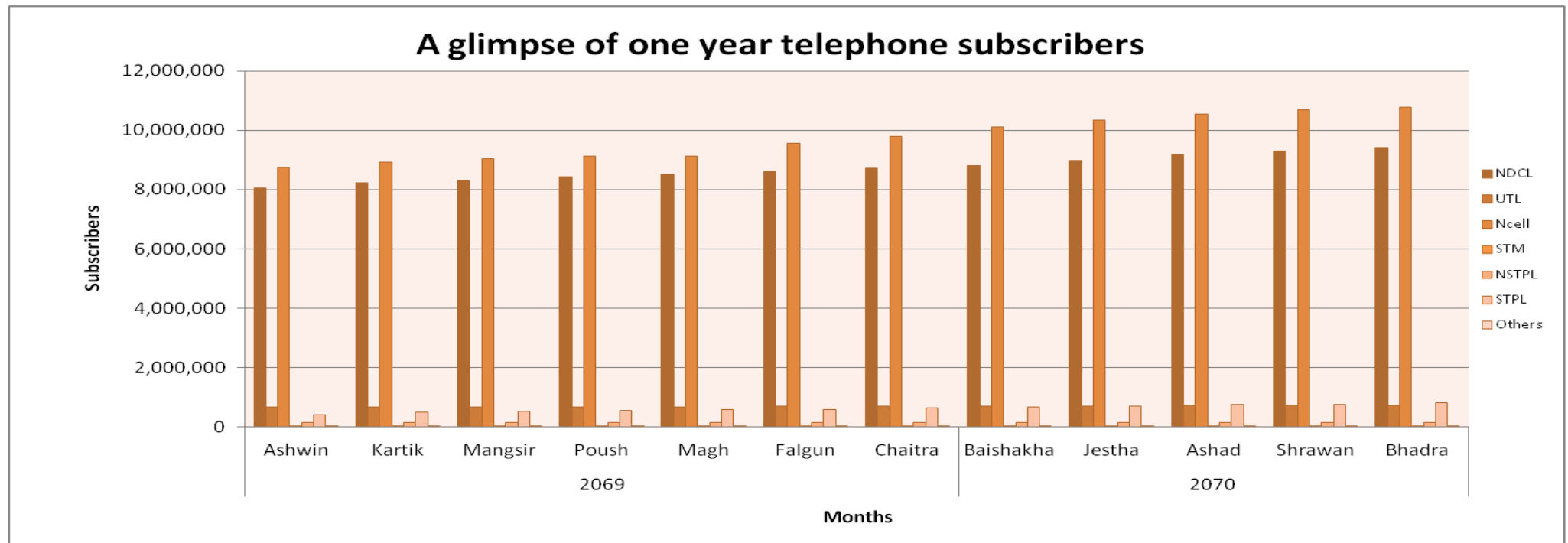
Growth Trend of Voice Telephone and Data Service Penetration
